BIDDING

Applicability to

Lease purchase; active lessor who selects contractors and controls all aspects of construction with only incidental participation by board is not required to put construction contract out to bid (91:100, Biehn)

Lease purchase; public bidding issue dismissed as moot in light of 1992 amendment to N.J.S.A. 18A:20-4.2(f) requiring bidding and completion of building project (O'Shea v. Franklin, 127 N.J. 244 (1992))

Public Records

Bids are both common law and statutory public records. Bidder entitled to inspect after opening and prior to formal award. Kuehne Chem. V. N.J. Water Comm., 500 N.J. Super. 433 (App. Div. 1997)

Yearbooks (95 N.J.A.R.2d (EDU) 42, Santomenna)

Asbestos safety control monitoring devices are not exempt under Public Schools Contract Law (94:March 31, Environmental Concepts)

Classification of bidders; pre-qualification

Board properly rejected all bids and re-advertised because specifications were ambiguous and bidders were not notified of statutory pre-qualification requirements; petition for emergent relief dismissed (90:1121, Williams Mobile Homes)

Damages, contractor not entitled to recover damages for lost profits; Public School Contract Law prohibits damages actions arising out of violation of its provisions (93 N.J.A.R.2d (EDU) 118, Bokey, aff'd St. Bd. 93 N.J.A.R.2d (EDU) 415)

Emergency exceptions

Board properly invoked emergency purchase exception under N.J.S.A. 18A:18A-7 when disrepair of school fire and security systems found to threaten the safety of students and personnel (97 N.J.A.R.2d (EDU) 115, Institutional) (See also, 94:July 11 Commissioner decision on motion denying request for stay and summary judgment)

BIDDING

Emergency: Motion for reconsideration of denial of damages to unsuccessful bidder denied; Commissioner did not reach issue of whether board properly awarded contract under emergency provision, as emergent relief sought was limited to damages (97:Aug. 29, Jayson Oil)

Emergent relief denied

No basis to warrant stay of any rebid contract or resulting work (96 N.J.A.R.2d (EDU) 789, DEC Electric)

Exemptions from Bidding

Asbestos safety control monitoring services are not professional services and, while they may be extraordinary unspecifiable services they are not exempt from bidding as they can be reasonably described by specifications (95:March 23, Environmental)

Installation of a CCTV surveillance system is not an extraordinary unspecified service exempt from bidding; petitioner's motion for emergent relief is granted and the district is ordered not to enter into a contract for the provision of CCTV services until it complies with the public bid process (97:Aug. 15, Radar Security)

No need to readvertise revised specifications where revisions negotiated; included in resolution awarding contract and adopted by 2/3 vote of the board (96 N.J.A.R.2d (EDU) 540, Rosenblum, aff'd State Board 96 N.J.A.R.2d (EDU) 743, aff'd App. Div. unpub. op. Dkt. No. A-0171-96T3, Oct. 20, 1997)

Services rendered to Board were specific, continuous and ongoing such that they did not qualify as "extraordinary unspecifiable services" under the statute (98:June 3, Middle Twp.; aff'd St. Bd. 98: Oct. 7)

Ninety day rule

No relaxation of 90-day rule warranted (96:March 8, J.R. Transportation)

Procedure

Actions for damages are prohibited by the Public Schools Contract Law (96 N.J.A.R.2d (EDU) 789, DEC Electric)

All bids must be rejected and project rebid where both petitioner and respondent were not in compliance with statutory provisions of N.J.S.A. 18A:18A-18 and N.J.S.A. 45:5A-9 (97:Aug. 19, Buena Plumbing, see also emergent relief denied 97:March 12)

BIDDING

- Appeal of low bidder moot where action was brought after contract had been performed; damages and attorney fees not available under pupil transportation statute (97:Oct. 1, Jordan)
- Bidder entitled to inspect after opening and prior to formal award. (Kuehne Chem. V. N.J. Water Comm., 300 N.J. Super. 433 (App. Div. 1997))
- Bid properly rejected - unwaivable, material defects (97 N.J.A.R.2d (EDU) 376, Murfield Construction)
- Bid subcontractor's petition challenging specific materials in bid mooted by contract competition by successful low bidder. (97 N.J.A.R.2d (EDU) 583, Eiden Associates)
- Board has the authority to reject all bids and readvertise a contract to provide district-wide window repair services, provided that rejection and readvertisement is not arbitrary and capricious (97 N.J.A.R.2d (EDU) 433, C & A Window Service)
- Board properly followed directives of PSCL by achieving the lowest available price from responsible bidders and by giving former bidders opportunity to participate in negotiations (96 N.J.A.R.2d 540, Rosenblum, aff'd State Board 96 N.J.A.R.2d (EDU) 743, aff'd App. Div. unpub. op. Dkt. No. A-0171-96T3, Oct. 20, 1997)
- Combined costs, roofing bids may be sought and awarded on combined basis (91:1667, Quality Roofing)
- Conjecture insufficient support in claim of collusion between school board and lowest bidder. (97 N.J.A.R.2d (EDU) 30, Expert Building)
- District has the authority to reject all bids and readvertise a contract to provide district-wide window repair services; bids not rejected solely because a protest had been filed (97:March 11, State Operated School District of Newark)
- Emergent relief, bus company not entitled to emergent relief from rejection of its bid for not being responsible (92 N.J.A.R.2d (EDU) 622, Wolffington Body Co.)
- Equitable estoppel did not bar corporation from challenging exemption from public bidding requirement, even where corporation had previously sought contracts using procedures it now attacks, because resolution of the question was a matter of public interest (95:March 23, Environmental)

BIDDING

- Hearing, board not required to provide hearing prior to rejection of all bids by qualified bidders (91:1431, Sempre Construction)
- Lowest bid properly awarded to lowest bidder; implication that lowest bidder was not responsible unsupported by facts (94 N.J.A.R.2d (EDU) 39, Krantz & List Electric)
- Lowest bid, rejection of lowest responsible bid by board because of preference for another bidder was arbitrary, capricious and unreasonable (93 N.J.A.R.2d (EDU) 228, Consec, aff'd St. Bd. 93 N.J.A.R.2d (EDU) 604)
- Modification of specifications placed in resolution awarding contract adopted by 2/3 vote of the board consistent with PSCL (96 N.J.A.R.2d (EDU) 540, Rosenblum, aff'd State Board 96 N.J.A.R.2d (EDU) 743, aff'd App. Div. unpub. op. Dkt. No. A-0171-96T3, Oct. 20, 1997)
- Mootness: contract that has been fully executed renders matter moot as there is no relief that could be legally awarded (97 N.J.A.R.2d (EDU) 503, Eiden Associates)
- N.J.S.A. 18A:18A-18 mandates the award of all prime contracts to the lowest responsible bidder be made at the same time, even if one or more exceed the architect's budgeted amount. Seacoast Builders, Inc. v. Howell Twp. Bd. of Ed., 315 N.J. Super. 442, but see Ch. 280, P.L. 1999.
- Petition properly dismissed. Annulled contract presented no concrete contested issue (96 N.J.A.R.2d (EDU) 789, DEC Electric)
- Prime trade; settlement re: procedures involving single prime trade and subcontractors (95:June 29, International)
- Project budget, architect could consider only base bids or equal, and not the alternative bid, where the base bid fell within the budgeted amount for the project (95:July 10, Wood-Metal)
- Qualifications; where successful bidder was not qualified, board has no obligation to award contract to second lowest bidder, particularly where there is a significant disparity between the amount of bids; board may rebid; second lowest bidder was not entitled to emergent relief (95:December 26, DEC Electric)
- Rejected bidder must file objections expeditiously where work in question is required early in the construction project, such as design and construction of premanufactured wood casement systems and equipment (95:July 10, Wood-Metal)

BIDDING

Rejection of all bids because of lack of necessary governmental permits and approvals was not arbitrary, capricious or unreasonable (91:1431, Sempre Construction)

Rejection of all bids followed by re-bidding contract impermissible when effect would be circumvention of Public Schools Contract Law (93 N.J.A.R.2d (EDU) 228, Consec, aff'd St. Bd. 93 N.J.A.R.2d (EDU) 604)

Rejection of bids due to inefficiency in repair contract affirmed. (97 N.J.A.R.2d (EDU) 533, C&A Window Service)

Responsible bidder, bid rejected as not responsible based on company's failure to deliver buses that met specifications under earlier contract (92 N.J.A.R.2d (EDU) 622, Wolfington Body Co.)

Standing: a bidder who is not the lowest responsible bidder lacks standing to challenge the award of a contract to another bidder (97:April 17, Eiden Associates)

Standing: contractor who did not challenge board rejection of 1st round of bids and who failed to participate in 2nd round of bids lacked standing to challenge award of contract (93 N.J.A.R.2d (EDU) 116, Green)

Standing: contractor who is not the lowest responsible bidder lacks standing to challenge the award of the contract (97:April 17, Eiden Associates)

Standing: taxpayers and corporation had standing to challenge exemption from public bidding (95:March 23, Environmental)

Standing: unsuccessful bidder lacks standing to challenge specifications after award of bids (94 N.J.A.R.2d (EDU) 307, Gavan, aff'd St. Bd. 94 N.J.A.R.2d (EDU) 500)

Standing: unsuccessful high bidder had no standing to challenge result since assertion was essentially an attack on the specifications and the fulfillment thereof by a rival bidder (97 N.J.A.R.2d (EDU) 30, Expert Building)

Standing: unsuccessful bidder may not challenge legality or sufficiency of specifications after award (93 N.J.A.R.2d (EDU) 1, Katinsky)

Ultra vires, award of transportation contract to company that could not conform to specifications was ultra vires act; no need to rescind contracts, board never legally entitled to award (92 N.J.A.R.2d (EDU) 635, Hudson County Transport)

BIDDING

Specifications

- Additional information, board has right to require information beyond that contained in Division of Building Construction certificate; bid of contractor who failed to supply additional required information properly rejected (94 N.J.A.R.2d (EDU) 307, Gavan, aff'd St. Bd. 94 N.J.A.R.2d (EDU) 500)
- Ambiguous specifications, board properly rejected all bids and re-advertised because specifications were ambiguous; bidders were not notified of statutory pre-qualification requirement; petition for emergent relief dismissed (90:1121, Williams Mobile Homes)
- Ambiguous specification, description must be sufficiently clear to set up common standard of bidding (90:74, Murphy Bus, aff'd St. Bd. 90:93)
- Ambiguous specification, failure to submit a compliant bid with sufficient data to enable architect to consider the bid is a material defect, and submission of alternative bid was improper under those circumstances (95:July 10, Wood-Metal)
- Ambiguous specification, remedy for vague specs was to re-bid to avoid penalizing good faith successful bidder and public (90:74, Murphy Bus, aff'd St. Bd. 90:93)
- Amendment by adoption of resolution at public meeting with subsequent newspaper advertisement provided sufficient notice of change in specifications to all potential bidders (91:1667, Quality Roofing)
- Bid properly rejected - unwaivable, material defects. (97 N.J.A.R.2d (EDU) 376, Muirfield Construction)
- Board ordered to reconsider bids consonant with the restrictions and purposes of public schools contracts law (97 N.J.A.R.2d (EDU) 376, Muirfield Construction)
- Bulk bid: Commissioner orders re-bidding where specs did not constitute clear authorization for bulk bidding (90:74, Murphy Bus, aff'd St. Bd. 90:93)
- Changes made to specs did not cause project to exceed authorized budget sanctioned by the voters; board did not overstep authority (96 N.J.A.R.2d (EDU) 540, Rosenblum, aff'd St. Bd. 96 N.J.A.R.2d (EDU) 743, aff'd App. Div. unpub. op. Dkt. No. A-0171-96T3, Oct. 20, 1997)

BIDDING

- Collusion, challenge to award dismissed on board's motion for summary judgment; allegation of collusion rested on conjecture, unsuccessful higher bidder had no standing, contract had already been fully performed, and there existed no basis for compensatory or punitive damages under N.J.S.A. 18A:18A-46 (97 N.J.A.R.2d (EDU) 30, Expert Building)
- Deviation from specifications was a material unwaivable defect which invalidated the bid (97 N.J.A.R.2d (EDU) 376, Muirfield Construction)
- Equivalent, board ordered to reconsider bids; record must demonstrate how the alternatives proposed by unsuccessful bidders were not equivalent to items requested (90:1646, DeHart, decision on remand, 91:395)
- Executive Order allowing project labor agreements contemplated using PLA's for very large, complex projects and not routine project like public library construction. Tormee Construction v. Mercer County Inc., 143 N.J. 143 (1996)
- Experience, board may require that bidder show that it is providing services in at least four New Jersey school districts (95 N.J.A.R.2d (EDU) 235, Stroh)
- Immaterial defect, omission of prequalification affidavit in bid for contract was a waivable, immaterial defect. Board's denial of waiver was an abuse of discretion. Tec Electric v. Franklin Lakes Bd. of Ed., 284 N.J. Super. 480 (Law Div. 1995)
- Late bid, failure to contain estimate for alternative plan unavailable material defects. (97 N.J.A.R.2d (EDU) 376, Muirfield Construction)
- Material defect must be of such a nature that its waiver would adversely affect competitive bidding by placing a bidder in a position of advantage. Tec Electric v. Franklin Lakes Bd. of Ed., 284 N.J. Super. 480 (Law Div. 1995)
- Material deviation of low bidder: Board may reject all bids and re-bid; good faith found (90:692, Barker Bus)
- Modification of specifications placed in resolution awarding contract adopted by 2/3 vote of the board consistent with PSCL (96 N.J.A.R.2d (EDU) 540, Rosenblum, aff'd St. Bd. 96 N.J.A.R.2d (EDU) 743, aff'd App. Div. unpub. op. Dkt. No. A-0171-96T3, Oct. 20, 1997)

BIDDING

- Motion for emergent relief seeking board to rescind contract denied as specifications were not left out of the bid package, but petitioner failed to include everything that bid package required (96:Aug. 28, Dean Equipment and Furniture)
- Non-collusion statement, short term waiver of statement of non-collusion not a substantial or consequential deviation that should invalidate bidding process (93 N.J.A.R.2d (EDU) 553, University Bus Company, appeal dismissed St. Bd. 94 N.J.A.R.2d (EDU) 223, aff'd App. Div. unpub. op. (Dkt. No. A-3039-93T3, May 2, 1995))
- Precise, specification requirement of 36 passenger bus definite, developed to address needs of special education pupils (92 N.J.A.R.2d (EDU) 635, Hudson County Transport)
- Precise, specifications asking for "IBM compatible" computers did not require submission of brand name (93 N.J.A.R.2d (EDU) 1, Katinsky)
- Project labor agreement specifications which limited work force to two unions, impermissibly restricted contractors to union-only work force and conflicted with public bidding laws. Tormee Construction v. Mercer County Inc., 143 N.J. 143 (1996)
- Representative; failure of low bidder to have a, present at second pre-bid meeting was minor and inconsequential deviation from bid specifications lawfully waived by board (91:327, Thomas & Sons)
- Safety features, board insistence on safety features available only from one manufacturer not evidence of favoritism, extravagance or corruption; record shows equivalency of alternative offerings were seriously considered (91:395, DeHart, on remand from, 90:1646)
- Standard of review for denial of waiver of immaterial defect in bid for public contract is ordinary abuse of discretion standard. Tec Electric v. Franklin Lakes Bd. of Ed., 284 N.J. Super. 480 (Law Div. 1995)
- Standing, unsuccessful bidder may not challenge legality or sufficiency of specifications after award (93 N.J.A.R.2d (EDU) 1, Katinsky)
- Stay of order to re-bid bus contracts denied, pending appeal of decision to State Board (90:March 26, Murphy Bus Service)

BIDDING

Transportation contracts

Annual bid, condition that a school bus transportation contract bid be submitted on an annual basis was material and non-waivable (90:692, Barker Bus)

Bulk bidding must be clearly authorized in specs (90:74, Murphy Bus, aff'd St. Bd. 90:93)

Material specification, condition that a school bus transportation contract bid identify vehicles was material and non-waivable (Barker Bus, 90:692)

Routes, district's special education transportation policy of bidding based on number of buses required rather than individual routes violative of competitive bidding requirements and not required by N.J.A.C. 6:28-3.8(a)(5) (94 N.J.A.R.2d (EDU) 156, Newark v. Division of Compliance)

While an unsuccessful bidder may attack the award of a contract, that bidder may attack the award of a contract, that bidder may not recover money damages even if the challenge succeeds (97:Aug. 29, Jayson Oil)

BILINGUAL EDUCATION

Regulatory change shifting proficiency evaluation from state to local school districts deemed valid. Violated neither the intent nor mandate of Bilingual Education Act. In re N.J.A.C. 6:11-8.4, 8.5, App. Div. unpub. op. (Dkt. No. A-2509-89T5, June 18, 1991))

BOARDS OF EDUCATION

Actions by, generally

Absenteeism policy, sets forth blanket denial of increments based on number of days missed; removes board from assessing the circumstances of the absences; arbitrary and contrary to law. Pollard, Griskind & Sims, App. Div. unpub. op. Dkt. No. A-4109-91, Feb. 22, 1994, aff'g St. Bd. 92 N.J.A.R.2d (EDU) 286, stay den. 92:July 1, rev'g 92 N.J.A.R.2d (EDU) 279)

Abstention, misunderstanding by board members of impact of abstentions does not invalidate vote electing board president (90:967, Schill)

BOARDS OF EDUCATION

Board and school administrator never reached agreement on contract; deductions for health insurance co-payments based on proposed contract improper - must be refunded. 95 N.J.A.R.2d (EDU) 35, Granaldi)

Board decision to remove principal after evaluation of performance was not arbitrary, capricious, or in violation of constitutional rights (96 N.J.A.R.2d (EDU) 926, Plotkin)

Board did not act improperly in denying mother's request to place pupil in district's Alternative High School (98:May 15, P.S.)

Board failed to comply with N.J.S.A. 18A:37-2.1. No expulsion hearing scheduled. Suspension not kept in effect pending expulsion proceeding (96 N.J.A.R.2d (EDU) 567, Garrity)

Board may properly deny admission to student for failure to undergo a mantoux test or failure to provide documentation that the student should be exempted from the mantoux test. (97 N.J.A.R.2d (EDU) 486, M.F., appeal dismissed, St. Bd. 97:July 2)

Board may reappoint nonrenewed employee without CSA recommendation after employee's informal appearance before the board (97:Aug. 6, Velasquez, St. Bd. aff'g w/modif. 96:April 4)

Board of education's refusal to rescind resignation not arbitrary, capricious or unreasonable. (97 N.J.A.R.2d (EDU) 53, Walsh)

Board ordered to immediately conduct expulsion hearing for students who committed assaults on teachers. N.J.S.A. 18A:37-2.1 (96 N.J.A.R.2d (EDU) 567, Garrity)

BOARDS OF EDUCATION

- Board policy banning backpacks in the classrooms, hallways and cafeteria in the interest of safety rationally based valid exercise of discretion (96 N.J.A.R.2d (EDU) 762, C.M.)
- Board's decision not to extend minibus service to petitioners was arbitrary and capricious (97 N.J.A.R.2d (EDU) 416, Shrewsbury, St. Bd. rev'g 96 N.J.A.R.2d (EDU) 795)
- Board's decision to suspend rather than expel pupil who assaulted teacher not improper or unethical. (97 N.J.A.R.2d (EDU) 345, Barna, dismissed St. Bd. 97:Nov. 5) (See also 96 N.J.A.R.2d (EDU) 598)
- Board's failure to hold expulsion hearing for student who assaulted teacher not improper where behavior primarily caused by disability. Regulation in place required evaluation of non-disabled student prior to expulsion (96 N.J.A.R.2d (EDU) 598, Barna, See also 97 N.J.A.R.2d (EDU) 345, dismissed St. Bd. 97:Nov. 5)
- Board's post referendum change from two story to one story school plan was within its discretion and was not unlawful, arbitrary, capricious or unreasonable (96 N.J.A.R.2d (EDU) 670, Shuster)
- Certification of tenure charges
Board's refusal to certify tenure charges against teachers accused of misappropriating student funds was not arbitrary, capricious or unreasonable given lack of conclusive evidence (93 N.J.A.R.2d (EDU) 288, Bey)
- Collective bargaining agreement; challenged on basis of undue influence and failure to provide details to residents, media, and some board members. Commissioner dismissed challenge for petitioner's failure to cooperate; also, union necessary party (95:November 15, Mueller)
- Decision not to appoint certified teaching staff member as head basketball coach is not an arbitrary, capricious or unreasonable where applicant leaves a coaching position where he is also a teacher to seek another coaching position at another school in the same district (96:Aug. 1, Krupp, on remand from State Board)
- Delegated authority, board properly delegated authority to monitor scheduling and training of maintenance workers (91:1486, Windham)

BOARDS OF EDUCATION

Discipline imposed (home instruction, community service, letter of apology) on student involved in a bomb threat was not arbitrary, capricious, or unreasonable (96 N.J.A.R.2d (EDU) 897, L.F.)

Discretion, board decision to bar parent who struck visiting coach during baseball game from attending all future athletic events upheld as within board's discretion (95 N.J.A.R.2d (EDU) 85, Griffin, appeal dismissed as moot 95:Apr. 5)

Discretion, board's discretionary power conferred by statute to relocate classes cannot be delegated to superintendent (93 N.J.A.R.2d (EDU) 577, Bond)

DOE justified reduction of state aid (\$274,273) where board had received \$925,000 donation from municipality. (96 N.J.A.R.2d (EDU) 867, Lacey, aff'd St. Bd. 96:Dec. 4)

Employees, board may not refuse to allow to testify during Comprehensive Compliance Investigation; no right to presence of counsel or court reporter (94 N.J.A.R.2d (EDU) 9, In the Matter of the Comprehensive Compliance Investigation of the School District of Newark, aff'd App. Div. 276 N.J. Super. 354 (1994))

Expenditure of funds: union's application for restraining order denied; board could not be restrained from spending moneys restored in budget appeal for items other than teachers' salaries, where collective bargaining agreement had not yet been reached (95:June 7, South River Ed. Ass'n.)

Expulsion upheld; student assaulted another student, brandished large knife and threatened welfare of fellow students and teachers (95 N.J.A.R.2d (EDU) 110, D.B., aff'd St. Bd. 95 N.J.A.R.2d (EDU) 253)

Fraud, purposeful misrepresentation by board of purposes for which discretionary Supplemental State Aid was sought constitutes fraud (93 N.J.A.R.2d (EDU) 623, Lyndhurst, St. Bd. aff'g 91:Nov. 1) See also (93 N.J.A.R.2d (EDU) 621, St. Bd. rejecting settlement, retaining jurisdiction and staying matter pending SCI review)

BOARDS OF EDUCATION

- Health benefits, Boards may not enter into trust participation agreement with intermediary in order to provide health benefits for employees (93 N.J.A.R.2d (EDU) 802, Millstone Twp. Teachers Assoc.) But see St. Bd. 95 N.J.A.R.2d (EDU) 255, Millstone Twp. Teachers Assn., - L. 1995, c. 74 authorized boards to provide group health insurance through joint insurance funds (JIF's); challenge to pre-1995 trust agreement dismissed. Decision clarified St. Bd. 95:Sept. 6)
- Health benefits: question of whether contract between board and CIGNA is fixed-insurance policy as authorized by N.J.S.A. 18A:16-13, or form of self-insurance prohibited under Irvington, remanded; Department of Insurance should be asked to participate as *amicus* on issue of whether policy is fully insured (94:Nov. 3, Middletown)
- Immunity: School board was immune from suit brought by pupil whose daughter was born with congenital rubella after she received rubella vaccination at school. (Kemp v. State, 286 N.J. Super. 549 (1996))
- Indemnification for ethics violation is not covered by statute (96:Oct. 10, Passaic)
- Job requirement, requirement of two certificates to qualify for single position was not arbitrary or irrational, even if unique (Denney, 131 N.J. 626 (1993), rev'g 251 N.J. Super. 144 (App. Div. 1991), rev'g St. Bd. 90:1007, aff'g 90:974)
- Liability: Members of a school board were not individually liable for another member's allegedly improper opposition to a housing project. Active knowing assistance or participation in the wrongdoing might serve as a basis for a charge of individual or board responsibility. However, members failure to prevent the allegedly improper conduct was not enough to establish liability. Lake Lenore Estates, Associates v. Twp. of Parsippany-Troy Hills Bd. of Ed., 312 N.J. Super. 409 (App. Div. 1998).
- No board vote required on nonrenewal after informal appearance before the board (97:Aug. 6, Velasquez, St. Bd. aff'g w/modif. 96:April 4)

BOARDS OF EDUCATION

- Punitive damages; in an action under the Conscientious Employee Protection Act, a board of education may be liable for punitive damages for the egregious misconduct of the superintendent of schools and other high-level administrators.
