FLAG SALUTE - President Smith led the members in the Pledge of Allegiance.

MOMENT OF SILENCE – President Smith asked for a moment of silence for all those who suffer from violence of any kind and to hope for a more tolerant and peaceful society.

MISSION STATEMENT - President Smith led the members in reciting the Association's Mission Statement.

OPPORTUNITY FOR PUBLIC COMMENT – No public comments.

OATH OF OFFICE – As it was the NJSBA Board of Directors re-organization meeting the annual oath of office was administered to all members in attendance.

CODE OF CONDUCT – President Smith reviewed the requirement of NJSBA's Conflict of Interest and Code of Conduct policies. The Conflict of Interest and Code of Conduct policies ensure the avoidance of actual or potential conflicts, or the appearance of a conflict of interest in any action involving an Association contractor, consultant, or vendor with which the member has a personal interest, or a direct or indirect financial interest.

Accordingly, NJSBA requires each member to review these policies and fill out the conflict of interest questionnaire (GO/8250E) annually. Members will be emailed a form, GO/8250E, including Board of Directors Code of Conduct and the Board of Directors Conflict of Interest Certification, as well as copies of the relevant policies and regulation (GO/8250, GO/8312 and GO/8318R). Members were asked to complete the form and return it to NJSBA. The statement certifies that the NJSBA Executive Committee and Board of Director members have received, have read and will adhere to the Board of Directors Code of Conduct.

EXECUTIVE DIRECTORS REPORT - Dr. Purnell addressed NJSBA activities, and the progress made in enabling school districts to meet the challenges presented to them ensuring that members continue to benefit from essential training, advocacy, and direct service.

NJSBA Financial Update - NJSBA's financial performance for the new year has started strong. Dues collection is on target; 86% of dues have been collected for the fiscal year and payments continue to arrive regularly.

Each summer NJSBA's auditors conduct a thorough review of the Association's finances for the fiscal year that ends June 30. The auditors have completed their work, and the draft audit report was presented to the NJSBA Audit Committee. The auditors issued an unmodified or "clean" opinion of NJSBA's financial statements. The Board of Directors will receive the final audit report and will vote on it at the November 14 meeting.

Workshop 2025 - Workshop will feature over 200 training sessions, as well as an expansive exhibit floor, student performances and special events. The full agenda can be found on the NJSBA Workshop website as well as on the mobile app. The mobile app is available for download in the Apple and Google Play store by searching NJSBA Workshop 2025. Some new features for this year's conference as a result of member feedback include later session start times on Monday, more lunch options including food trucks, closed captioning and -more seating for keynote theater events, more interactive features in the Midway, bingo, more dedicated time on the exhibit floor, larger rooms for popular sessions, and jitneys running through the end of the School Law Forum.

County Association Leadership – Dr. Purnell attended the County Association Leadership meeting this past Saturday. Almost every county was represented. The meeting topic was "What can we do to help increase member's participation in county meetings?" Some of the suggestions included:

- Have the county officers go to local district board meetings to encourage participation.
- Have an officer who is charged with membership engagement.
- Involve more members besides the officers in the planning meeting discussion.
- Leave time at the end of the meeting for networking.

NJSBA LEAD - To support the leadership growth of New Jersey's school board presidents and vice presidents, NJSBA is proud to offer NJSBA LEAD: Leadership Excellence and Development – an executive coaching program. This new fee-based program offers one-on-one and group coaching opportunities to help bolster key leadership skills, including decision-making, effective communication, conflict resolution, fostering a collaborative environment, and more. Many leaders step into these roles without formal training—this program fills that gap with professional coaching tailored to the unique challenges of school board governance. Participants in NJSBA LEAD will be coached by Dr. Kimberley Harrington Markus, ICF-certified coach and former NJ Commissioner of Education.

Facilities Update - NJSBA plans to renovate the first-floor conference room at headquarters. The RFP Notice for the renovations was published on July 25, and packets were emailed to prospective bidders beginning the week of July 28. Twelve inquiries were received from general contractors who expressed interest in the RFP notice and requested all necessary documents. A pre-bid meeting was held August 5, which included the architect, Alfredo Trevino Architects. An alternate collapsible wall door was suggested. Due to the Addendum proposed for an alternate door and a few questions from bidders, the opening of bids date was moved from August 26 to September 3 and then to September 10 in order to allow for proper notification to all prospective bidders. The bid opening was successfully completed on September 10 with two responsive bids being filed, one by Global Connections Contractors Inc., and the other by Scozzari Builders Inc., both based in Trenton. Immediately following the bid opening, NJSBA received a letter from Scozzari protesting certain technical aspects of the response from Global Construction. General Counsel Carl Tanksley is reviewing, while Charles Muller and Bill Cobb evaluate both bids for compliance.

President Smith asked for a motion to approve the extension of payment of dues for BOD Members' boards until the November 14, 2025 Board of Directors meeting.

Background: As of September 19, there are five (5) Board of Directors members who are members of a board of education from which NJSBA has not yet received the 2025-2026 dues. NJSBA has received purchase orders or verbal commitments from these districts that the dues payments have been or will shortly be processed. However, the NJSBA Bylaws require that the Board of Directors vote to extend the timeline since the payment has not yet been received.

Diane Morris moved to APPROVE the extension of payment of dues for a BOD Members' board until the Nov. 14, 2025 Board of Directors meeting. The motion was duly seconded and carried, with 21 members voting in the affirmative. The following member abstained from voting: Addie Lane.

President Smith asked for a motion to approve the appropriation of \$200,000, from the free balance account, for future facility upgrades.

Lou Della Barca moved to APPROVE the appropriation of \$200,000, from the free balance account, for future facility upgrades. The motion was duly seconded and carried, with 22 members voting in the affirmative.

President Smith asked for a motion to approve the award of contract to Suplee, Clooney & Company, LLC to perform an audit of NJSBA financial statements for the fiscal year ended June 30, 2025.

Victoria Pakala moved to APPROVE the award of contract to Suplee, Clooney & Company, LLC to perform an audit of NJSBA financial statements for the fiscal year ended June 30, 2025. The motion was duly seconded and carried, with 22 members voting in the affirmative.

President Smith asked for a motion to approve the increase to the bid threshold amount of \$39,000.

Liwu Hong moved to APPROVE the increase to the bid threshold amount of \$39,000. The motion was duly seconded and carried, with 22 members voting in the affirmative.
